1. INTRODUCTION

The term IoT refers to scenarios where network connectivity and computing capabilities are extends to objects, sensors and everyday items not normally considered as computers thereby allowing the devices to generate, exchange and consume data with minimal human intervention (Internet Society, 2018). IoT is all about advanced automation and analytics system which exploits networking, sensing, big data and artificial intelligence technology to deliver complete systems for a product or service. It gives system a greater transparency, performance and control when applied to any industry or system.

IoT systems have applications across industries through their unique flexibility and ability to be suitable in any environment. They enhance data collection, automation, operations and many more through intelligent devices with powerful enabling technologies (Internet Society, 2018).

Higher educational institutes (HEIs) are the organizations responsible for imparting knowledge to people. They provide avenues where students interact with the teachers in exhibiting their talents and potentiality. Teaching and learning in these institutions are usually done through classroom interactions. Introduction of IoT into education sector has brought a complete model for smart sharing of information and educational resources in the various institutions of learning. The IoT concept in education will usually provide three (3) dimensional impact model involving stakeholders, applications, and learning methods (Jain and Chawla, 2021).

IoT is refer to a network that connects any objects with the internet based on the specified protocols or procedures through equipment with information sensing capabilities. These equipment or devices conduct information exchange and communication with the view to achieve smart recognitions, positioning, training, monitoring and administration (Patel and Patel, 2016).

The communication media could be through radio frequency identification (RFID), wireless local area network (WLAN), wide area network (WAN) or any other means. Any or everyday objects include electronics and smart devices as well as objects that are not electronics such as food, clothing, chair, animal etc. IoT is a new revolution of internet that make objects recognize themselves as well as to obtain intelligence in making or enabling context related decisions. IoT is divided into three (3) categories which include people to people, people to machine, and machine to machine. It can also be characterized with issues like things-related services, heterogeneity, dynamic changes, enormous scale, safety and connectivity (Patel and Patel, 2016). They identified four different layers of technologies that usually stands as IoT architecture:

- a. Smart device/sensor layer: This is the lowest layer of IoT that consist of smart objects integrated with servers. The sensors create connection among the smart objects and devices with real-time information to be collected and processed. Most sensors usually require communication channel or connectivity to the sensor gateways such as local area network (LAN) like ethernet and Wi-Fi connections or personal area network (PAN) like ZigBee, Bluetooth and Ultra-Wideband (UWB). There are sensors that doesn't require connectivity to sensor gateways. In that case, they connect through backend servers or applications using wide area network (WAN) such as GSM, GPRS, and LTE.
- b. Gateways and Networks: this is the robust and powerful transportation medium with high performance in a form of wired or wireless network infrastructure.
- c. Management Service Layer: This layer handles data and information processing through analytics, security measures, process modelling and management of devices and sensors. IoT creates connection and interactions between objects and systems which in-turns provide



information in form of events or contextual data such as data related to temperature, locations, traffic, etc. This numerous data requires filtering and reordering according to intended recipients. Management service layer (MSL) handles that process and ensure a responsive IoT system.

d. Application Layer: This brings about creating smart environments or spaces for both objects and sensors to interact and share resources or information. It covers domain areas like transportation, building, city, lifestyle, agriculture, healthcare, etc.

Sometimes, educators introduced the use of IoT in educational institutions for safety measures. This is achieved through wearable devices, video monitoring and threat detection within the educational institutions. It can be leads to improvement of learning and quality monitoring of learners and instructors (Palanivel, 2019). IoT can play significant role in improving quality of learning and enhancing performance of the learners, support teachers' daily routine activities, manage school premises as well as regulate school transport systems (Zeeshan, Hamalainen, and Neittaanmaki, 2022).

Therefore, this paper will explore the mechanism to adopt IoT within HEIs so that teachers and student can use their smart devices towards enhancing teaching and learning process. This can be achieved with the following objectives:

- i. To identify the benefits of IoT in HEIs
- ii. To provide stages of IoT implementation in HEIs
- iii. To provide model description of the implementation stages for successful development and deployment.

1	Smart Campus	Most campuses in HEIs are connected to the Internet, and consists of multiple objects like windows, doors, projectors, printers, classrooms, labs, parking, and building, etc. Adopting the use of IoT technology using sensors, RFID etc. can convert these multiple objects to smart objectives with high performance. A Smart Campus can be a collection of multiple smart objects in a single system which will turn the campus into intelligent campus containing features like smart E-learning Application with, smart classroom, smart laboratory, sharing of notes and mobile devices through sensors, smart-enabled hotspot for the entire campus. The smart campus can have additional features for smart tracking of students' whereabout, smart corridors with smart notice boards can also be created for data processing and sharing.
2	Smart Classroom	Smart classroom will create an intellectual environment that is equipped with recent advanced and high-performance learning tools. These smart objects or tools can be cameras, microphones or other sensors that can be used to measure learning outcomes such as student satisfaction regarding the learning process and other classroom activities. It also eases the process of class management with lots of comfort to both teachers and students. For example, it makes it possible for teachers to decide when to speak louder especially when students are losing interest while lessons are going. Smart classrooms also allow teachers to know the learning requirement for each student as well as brings more productivity in HEIs.
3	Smart Classroom Attendance	In conventional classroom management, taking attendance of a class is usually a time-consuming task. Adoption of IoT can save time and enhance efficiency. A smart classroom roll caller system (SCRCS) with IoT architecture will collect or record students' attendance after every period accurately and timely. Sensors or RFID tags will be attached to the Students' ID cards.

Therefore, feedback from the students play a vital role to improve lecture quality. IoT-based smart classroom provides real-time feedback on lecture quality which will help to improve the lecture quality.
